ScottishPower and Shell have joined forces to develop the MarramWind floating offshore windfarm, located 75km off the north-east coast of Aberdeenshire.

The windfarm will consist of floating wind turbines that could deliver up to 3 gigawatts of renewable energy – enough renewable electricity to power the equivalent of more than 3.5 million homes. MarramWind will play a pivotal role in helping achieve Scottish and UK net zero targets and supporting the UK's pursuit of energy security and self-reliance.

The energy generated by the wind turbines will be collected by offshore substation platforms and transmitted to shore via subsea cables. From shore, onshore underground cables will connect to onshore substations for onward connection to the electrical power grid.

Booing 'won't be censored' at Eurovision

Eurovision Song Contest organisers have said they will not "censor" the audience at the second semi-final in Malmo, Sweden, after Israel's entry Eden Golan was booed during rehearsals.

Golan will be one of the last performers at Malmo Arena with her song Hurricane, which was reworked from an earlier track called October Rain, thought to be a reference to the date of the Hamas attack on Israel in which hundreds of people were kidnapped and killed.

She was booed by some of the spectators watching rehearsals on Wednesday and there were reportedly shouts of "free Palestine".

"Just like in all major TV productions with an audience, SVT work on the broadcast sound to even out the levels for TV viewers," a statement from the Eurovision organisers, including Swedish host broadcaster SVT, said.

"This is solely to achieve as balanced a sound mix as possible for the audience;

and SVT do not censor sound from the arena audience.

"The same principle applies to all competing performances and opening and interval acts.

"The EBU (European Broadcasting Union) and SVT encourage all audiences to attend in the spirit of the contest, embracing its values of inclusivity, celebrating diversity and being united by music."

Yesterday, Greta Thunberg, 21, was at the Stop Israel demonstration, between Stortorget and Møllepladsen in the centre of the Swedish city ahead of Golan's performance.

The environmental activist was wearing a keffiyeh, a scarf commonly used to show support for Palestine, around her body in the centre of the crowd.

During the march, Stockholm-born Thunberg refused to comment apart from telling the PA news agency that she was "good" while flanked by other young activists.

Swedish police have

estimated between 10,000 to 12,000 people took part in the protest march.

There was a banner created with Eurovision-style branding with the words "genocide" on it, an accusation vigorously denied by Israel amid the war with Hamas which was sparked by the October 7 killings and kidnappings of hundreds of Israelis.

The sign was later taken to Malmo Arena, where activists handed out leaflets making similar allegations.

At a protest in Malmo, Rory Flynn, 27, from Kildare, part of the Eurovision Irish fan club, said he was part of a "separate movement" to protest against Israel, adding the country's entry is "overshadowing the competition".

He said: "We feel that it's important to make our voices heard in the arena.

"Others are doing a full boycott – and full respect to people who are doing a full boycott – but we think it's important that our voices are heard in the arena and around Malmo."

Mr Brightside becomes UK's top selling song never to reach No 1

Iconic 2003 track Mr Brightside by the Killers has usurped Wonderwall by Oasis as the longest-running song in the UK top 100 chart without ever actually claiming the No 1 spot.

According to the Official Charts Company, Mr Brightside's 5.57 million combined sales and streams also makes it the UK's third biggest song of all time.

Elton John's Candle in the Wind '97/ Something About The Way You Look Tonight and Band Aid's Do They Know It's Christmas remain No 1 and No 2, respectively.

Mr Brightside has a total of 530.3m streams – 100 paid streams or 600 free streams equal one "sale" – and has sold 1.1m copies since its initial release over 20 years ago.

The song has spent 408 weeks – seven years – in the UK top 100.

Its closest competitor is Lewis Capaldi's Someone



Brandon Flowers.

You Loved, which trails behind at 234 weeks in the top 100.

Brandon Flowers, who wrote the iconic track with bandmate Dave Keuning, told the Official Charts Company that he now feels like the song is not even theirs.

"It's funny. I don't feel so much of it anymore. It just exists in the world," Flowers said.

"It's amazing that I had something to do with it, but I almost feel a little bit removed from it because it's so big."

The enduring track is still being streamed 1.8 million times per week by Britons.

There is no sign of it slowing, either, with last year representing the track's biggest year of streams, with 79.97 million plays.

In 2024, Mr Brightside is accelerating further still with average combined weekly sales and streams up 23% year-on-year.

On his first indication of the song's impact, 42-year-old Flowers said: "The John Peel stage at Glastonbury (in 2004).

"We'd been coming to the UK and had some great experiences, but we'd been away for a little while. We came back, and when we played that song something had happened. A change had happened.

"Something shifted in the way that the audience physically responded, and it set us off on this path to become the live band that we are now."

U-turn call on closures overnight

More than 90 per cent of residents say the overnight closure of three Aberdeenshire minor injury units will have an impact on their family.

A recent survey conducted by Aberdeenshire Health and Social Care Partnership found 2,177 (91 per cent) of people would be detrimentally affected by the change in opening hours to Fraserburgh, Huntly and Peterhead minor injury units.

Aberdeenshire West MSP Alexander Burnett and Buckie-based MSP Tim Eagle said the survey results highlight the need to reverse the decision to cut overnight opening hours at the three facilities.

Politicians met NHS Grampian bosses on Friday to raise concerns about a number of issues, including MIU accessibility.

But there is hope the overnight closures may be U-turned when a paper outlining the impacts of the decision is published early next year.

The data, gathered throughout the six months

since the closure, will look at the impact on the wider out of hours health care system, including attendances at the emergency departments at Aberdeen Royal Infirmary and Dr Gray's, and the resulting pressure on the Scottish Ambulance Service and GMED services.

In the new survey recently published, there were 1,092 responses relating to concerns on the increased distance to access treatment overnight. These comments included fears about the lack of public transport and travel costs, particularly for those who don't drive or own a vehicle.

There were also 834 responses relating to concerns about accessing local health care overnight.

A total of 310 concerns were raised about what would happen in the event of a medical emergency in the overnight period. This included concerns about who to turn to in the event of a stroke, heart attack, anaphylaxis or severe blood loss.

Mr Burnett, said: "This survey sends a clear message that closing Huntly, Fraserburgh and Peterhead minor injury units overnight is the

wrong decision.

"The people of the North East shouldn't have to wait months after the decision had already been made for this survey to be published and for their voices to be heard.

"This and the sheer lack of consultation sends the wrong message to the public whose rural healthcare services are being cut to the bone.

"Since these cuts have been implemented, I have heard first-hand how patients are now living in fear if a medical matter arises overnight, with many being forced to wait until the morning to be seen or in some cases, not bother at all due to the lack of local health provision available.

"When the new paper outlining the impacts of this decision is published early next year, I hope this deeply damaging move can be reversed to protect the needs of our communities."

Mr Eagle added: "These minor injury units provide a lifeline service to people, especially for those living in rural areas, and this survey underlines the strength of anger among communities by this decision."

Low overnight numbers and a need to make savings

Overnight closures of the Minor Injury Units in Fraserburgh, Peterhead and Huntly were introduced in July this year.

They now operate from 7am with the first available appointment at 8.30am and the last available appointment for a minor injury presentation at 7pm.

At the time the changes were introduced, John Tomlinson, chair of the Integrated Joint Board (IJB), said: "We know that change can be unsettling and this decision, to alter the opening hours of the three MIUs, has not been taken lightly; it rests on a strong foundation of data collected over many months – which shows a low number of minor injury presentations overnight."

Councillor Anne Stirling, IJB vice chair, added: "Like much of the public sector we are facing significant budgetary pressures and will need to make efficiencies and savings of over £20m

this financial year to ensure that health and social care services for our most vulnerable residents are sustainable into the future."

The minor injury service and the out of hours GP services (GMED) are both accessed by calling NHS 24 on 111 and people should not arrive at any of the units without an appointment.

You should call NHS 24 on 111 when you think you need A&E but it's not life or limb threatening; you need support with mental health distress; or you need urgent care, and your GP, pharmacy or dental practice is closed.

Always call 999 in a medical emergency – when someone is seriously ill or injured and their life is at risk.

Construction begins on major electricity project

Construction work on what will be the UK's single biggest ever electricity transmission project took a step forward with a simultaneous ground-breaking ceremony in Scotland and England at each end of the 2GW subsea link.

Representatives from SSEN Transmission and National Grid Electricity Transmission (NGET), who will deliver the £4.3bn EGL2 project as a joint venture, took the first ceremonial spadefuls of earth at events in Peterhead and Drax in North Yorkshire on Thursday.

At more than 500km in length, the project includes what will be the longest

HVDC subsea cable in the UK (436km), and will provide enough green electricity to power around two million

homes.

The project will support hundreds of skilled jobs during the construction phase

and thousands more through supply chain activity.

Gregor Alexander, chair of the SSEN Transmission

board, was joined in Peterhead by representatives from SSEN Transmission and NGET, and industry regulator Ofgem.

Key supply chain partners were also present – Prysmian will manufacture and install the cable; and Hitachi Energy and BAM will supply converter stations at either end of the link.

Mr Alexander, said: "Today's groundbreaking is a landmark day in this nationally critical infrastructure project, and testament to a huge collective effort from the project teams at SSEN Transmission and NGET who have worked tirelessly to get us to a stage where construction work can begin."

"EGL2 will play a major role in bolstering energy security and contributing to

net zero targets, and it will also generate jobs and provide a legacy to local communities here in the north-east of Scotland, where our teams are already supporting local environmental initiatives."

Akshay Kaul, Ofgem's director general for infrastructure, added: "Harnessing homegrown clean energy will help build a secure energy future for Britain, and projects like EGL2 are pivotal in our move towards that."

"The part Scotland plays in achieving that goal cannot be overstated, and the long-term gains for Scottish bill payers, in terms of secure, more affordable, and cleaner power will be reaped for generations to come."

EGL2 is expected to be fully energised and operational in 2029.

Welcome news on GB Energy

Aberdeenshire Council Leader Gillian Owen has welcomed the UK Government's announcement that Aberdeen is to be the home of the new state-owned energy company GB Energy.

Port is thriving – but further taxes will hit investment

Steve Murphy, Storegga executive vice president, welcomed the UK Government's recent pledge of £21.7bn for two Carbon Capture, Usage and Storage (CCUS) projects in England – but warned the government about the risk of delaying decisions on other energy transition infrastructure, including the Acorn CCUS project at St Fergus.

"Storegga is a British company, working with British partners to drive real change in Britain," he said. "But to do so we need policy clarity and consistency from Government – without which we'll find ourselves at a disadvantage to other countries and regions where there is a clearer path for investors to delivery – and returns."

Aberdeenshire North and Moray East MP Seamus Logan said: "I believe it is our job as politicians, whether in Government or opposition, to ensure that we encourage investment, that we focus our expenditure on the infrastructure of the future and that we provide clearly articulated support in the public realm so that bodies like Peterhead Port Authority can deliver on their vision and ensure economic growth and enhanced prosperity, both locally and to the wider Scottish and UK economies."

Guests were also provided

with an update on the ongoing £4.3 billion project to take offshore wind power from Scotland to the east coast of England, known as EGL2, which includes a 436km

stretch of cabling – from Peterhead to Drax in North Yorkshire – buried under the North Sea.

The project, highlighted by former oil and gas engineer Tom Moore, is expected to come on stream in 2029.

Peterhead Town Board is inviting feedback from local users on priorities for a potential £20 million in endowment funding for the town.

In March this year, Peterhead was added to the UK Government's 'Long-Term Plan for Towns' programme.

The programme announced a potential £20 million in endowment funding for Peterhead over 10 years from April 2025.

Peterhead Town Board must submit a plan to the UK Government, and have it agreed, before the programme starts.

The UK Government had asked that the Long-Term Plan for Peterhead be sub-

mitted by November 1 – but this deadline was suspended after the General Election.

The new Labour Government is currently reviewing its budget, and the final decisions taken at the end of October may impact on the future funding of the Long-Term Plan for Towns' programme.

Peterhead Town Board, though, has decided that it is essential to keep working on its plan so the town is in a strong position when the government's decision is made, enabling the board to move forward swiftly and take full advantage of any opportunities that may arise.

The Long-Term Plan must include a 10-year vision, and an initial three-year investment plan.

So the board is asking for local views on the right pri-

orities for the Long-Term Plan for the town.

The feedback received from the public will help the board to select the right priorities for the town.

The board may invest funding across three broad themes:

- Safety and Security;
- High Streets, Heritage and Regeneration;
- Transport and Connectivity.

‘Keep tourist tax proceeds on the island’

Local businesses have insisted that any money raised from a new tourist tax should remain on Skye.

Highland Council is holding a consultation on how the levy should work in the region.

It comes after MSPs approved a plan in May to introduce a visitor levy across Scotland.

This allows local councils to add a charge to overnight accommodation such as hotels, B&Bs and holiday lets.

Now, 99% of businesses on Skye that responded to a survey by destination organisation SkyeConnect on the proposed levy, want all the revenue raised on the island to be spent locally rather than go into a Highland Council pot.

The Highlands get more than six million visitors a year – including day trippers, overseas tourists and cruise passengers.

The council has yet to publish its plans in terms of the percentage charge on overnight accommodation.

However, Edinburgh City Council is proposing a year-round levy charged at 5% of the accommodation cost, capped at seven consecutive nights and applied across the entire local authority area.

Council chiefs in the capital are also proposing that 10% of revenue is ring-fenced for destination management.

SkyeConnect would like to see a similar commitment from Highland Council following the removal of core funding from all destination management organisations (DMOs).

SkyeConnect’s survey was sent to over 1,000 businesses and individuals.

The DMO received 185 responses with the vast majority (130) coming from the accommodation sector of the tourism industry.

When asked what a fair percentage levy on accommodation costs would be, 58% of all respondents opted for a 1-2% charge with 22% suggesting a 3-4% charge would be fair and 13% calling for a 5-6% levy.

However, among accommodation providers, only 72% of respondents favoured a 1-2% levy, 16% wanted a 3-4% charge and 8% backed a 5-6% levy.

The legislation only allows a levy to be charged per night on accommodation whether that be in a hotel, self-catering unit, B&B, campsite or hostel.

However, respondents to the survey wished the levy to be applied to other visitors, with 88%

saying campervans and motorhomes not staying in commercial campsites should be charged; 45% called for day visitors to be charged; 61% wanted the levy applied to cruise ship passengers, 66% for tour groups while 46% wanted wild campers to be included.

There is concern about the administrative burden the levy scheme will place on businesses, with 68% of respondents from the accommodation sector believing they should be compensated for collecting and administering the levy on behalf of the council.

SkyeConnect said it understands that there are currently no plans for Highland Council to exempt certain groups of people from paying the levy.

This is opposed by 77% of respondents to the survey with significant support for exemptions for healthcare workers, emergency service personnel people visiting relatives in hospital, people attending funerals and carers.

A Skye Connect spokesperson said: “We advocate for funds raised on Skye to be allocated locally, focusing on projects that enhance the visitor experience and support the local economy.”

Stolen kayak sparks coastguard’s five hour missing person search

A stolen kayak led to a frantic missing person search off the coast of Portgordon.

An HM Coastguard search team was mobilised at around 6.40pm on Monday after the kayak was found drifting off the harbour.

An appeal was launched to ask for information regarding the owner, while rescue teams searched the area.

In a later update, HM Coastguard Moray said the kayak had been stolen after the vessel’s owner was found safe and well via the online appeal.

The search was stood down at 11.30pm after a five-hour search off the Moray coast.

The coastguard have now thanked those who assisted in the search.

An HM Coastguard – Moray statement read: “Thank you to all the individuals and organisations that shared our earlier post for

information regarding a kayak found drifting off Portgordon harbour.

“The owner has been found safe and well following this appeal and it appears the kayak had been stolen earlier.

“Thank you for your assistance in resolving this matter and to the persons who promptly made the emergency call when they saw the kayak drifting.”

Last weekend, HM Coastguard – Moray had taken part in a water rescue training exercise on the River Spey near Fochabers.

The exercise simulated two four-man canoes capsizing, with an unknown number of casualties, and tested the collective response of multiple emergency services.

Top solicitor facing probe into finances

A top north-east solicitor has been stripped of his licence to practise law as an investigation into alleged financial irregularities gets under way.

Stuart Murray, a former president of the Aberdeen Bar Association and vice-president of the Scottish Solicitors Bar Association, has had his licence to practise criminal law suspended with immediate effect within all UK courts.

Mr Murray – who is based in Aberdeen – has also worked on some high-profile legal cases, including representing US fugitive Nicholas Rossi.

It is understood an investigation is ongoing into Mr Murray's financial activities and relates to his time with his previous firm.

The firm was dissolved earlier this year, with Mr Murray's former law partner launching his own practice in the city.

The Law Society of Scotland said its Client Protection Sub-Committee withdrew Mr Murray's

Practising Certificate earlier this month due to "breaches of the accounts rules that apply to all Scottish solicitors".

Mr Murray did not respond to requests to comment on the allegations.

A Law Society spokesman said the decision was made "in accordance with section 40 of the Solicitors (Scotland) Act 1980, which provides the Law Society with statutory powers related to accounts rules, including to ensure that proper records are kept and that client funds are protected".

"As the professional body for Scottish solicitors, we take our regulatory duties very seriously to ensure that people have confidence in the legal profession," he added. "Given that investigations may be ongoing, it would not be appropriate for the Aberdeen Bar Association to provide commentary on the specifics of this matter."

The Scottish Solicitors Bar Association confirmed that Mr Murray served as its former vice-president but that he was no longer an office holder. "In any case where we have reason to believe that one of our members has not met the standards expected of them, we will take action to ensure that clients are protected."

It added that it "wouldn't be appropriate to comment" while the investigation was ongoing.



I am writing to provide you with updates relating to the proposed MarramWind Offshore Windfarm and to invite you to participate in the third round of statutory consultation for the project. The consultation period will be open from 18 August 2025 until 9 September 2025.

About MarramWind

MarramWind is a proposed floating offshore windfarm being developed by ScottishPower and Shell, 75km off the northeast coast of Aberdeenshire. The project, one of the first commercial-scale floating offshore windfarms in the world, has the potential to produce up to 3 gigawatts (GW) of clean, renewable electricity, which would power the equivalent of more than 3.5 million homes.

Previous statutory consultation

The project undertook two rounds of statutory consultation in 2024. Each round consisted of two in-person events at Peterhead and Longside, online Q&A sessions with the project team, and a virtual exhibition hosted on the project's website. MarramWind is a proposed floating offshore windfarm being developed by ScottishPower Renewables and Shell, approximately 75km off the northeast coast of Aberdeenshire. The project, which would be one of the first commercial-scale floating offshore windfarms in the world, has the potential to produce up to 3 gigawatts (GW) of renewable electricity, powering the equivalent of more than 3.5 million homes, and providing a vital contribution towards the UK's carbon reduction and energy security goals.

Stakeholder engagement and consultation is a critical part of the development process, and we are committed to developing an offshore windfarm in a considered way that is sensitive to the needs and expectations of local stakeholders whilst creating long-lasting benefits and opportunities. The project conducted two rounds of statutory consultation in 2024, with events at Peterhead and Longside. In total, approximately 300 people from across Aberdeenshire took part and had their say at our in-person events, a virtual exhibition space, and online Q&As. The consultation booklets from the previous rounds of consultation are available on the project website: www.marramwind.co.uk.

The project had intended to submit its EIA Report to the relevant onshore and offshore consenting bodies in October 2025. 

CUTBACKS: Albyn School is seeking to 'minimise pressure' on school fees.

Top staff go as school acts to curb costs

BY ROSS HEMPSEED

Three senior members of Albyn School's leadership team have gone as part of a major shake-up.

The private school, on Queen's Road, issued a letter – seen by the Press and Journal – to parents announcing a number of departures.

The letter, signed off by head of school David Starbuck, confirms changes in senior leadership.

It says the steps have been taken to ensure "Albyn is aligned for the future" and help it meet financial pressures.

Mr Starbuck wrote: "A smaller team will allow us to work closely together, while keeping leadership costs proportionate."

"In doing so, we can focus our resources where they matter most – on teaching, on pupil support, and on minimising pressure on school fees."

The restructuring has resulted in the departure of three of the school's long-standing senior staff.

These are co-curricular life leader John Blundstone, senior teacher and exams officer Carly Blair and head of development



Albyn's head of school David Starbuck.

Frances Loughrey. Other staff have moved roles.

Nathan Davies, who served as head of lower school, will remain until October in an interim support role.

Mr Starbuck accepts their "absence will be felt".

He said: "One important change is that we no longer have a separate head of lower school."

"As head of school, I now hold overall responsibility, with senior colleagues taking clear leadership roles in both wellbeing and learning across all stages."

"This reflects and strengthens our one-school approach, ensuring redundancies in the coming weeks."

Several new staff have also joined the school, while a number of current staff have been given additional roles.

Mr Starbuck added: "With these changes and successes, Albyn moves forward into the new session aligned, focused and confident about the future."

A spokesperson for Albyn School said: "We can confirm that school leadership has undergone a restructure."

"That has been completed."

"The school is not intending to make redundancies in the coming weeks."

'Seismic change' for motor group as turnover grows by almost £13m

Motor group Dicksons of Inverness has seen its turnover grow by almost £13 million in its latest accounts.

The firm owns five dealerships across the Highland capital and has revealed it was a year of "seismic change".

The accounts for the year ending March 31 2025 show a pre-tax profit of £174,007 in its first year of a multi-million-pound management buyout.

They also show turnover rising to £58.4m, compared to £43.5m the year before.

Dicksons runs Kia, MG, Nissan and Suzuki showrooms, as well as its own affordable showroom, Carzar.

Managing director Fraser Bryce said the company is still on track to grow its turnover to £100m in the next five years.

Dicksons said there were substantial costs for several reasons over the 12

months. It invested £500,000 in its new Kia showroom as well as further investment in a rebrand.

The motor group said global issues around electric vehicles have also contributed to the rising costs.

Mr Bryce said: "The directors are happy with the continued growth with increased revenue across all dealerships and all departments.

"We are still on course

for our stated five-year forecast of staffing levels reaching 100, and turnover £80m."

The year's turnover was split between vehicle sales of £50.1m and after-sales revenue of £6.3m.

Mr Bryce and four other directors completed a management buyout last year. It is being driven forward by a five-team board of directors – Mr Bryce, Jim Mackenzie, Jamie Dunlop, Douglas Laird and Linda MacPhie.





And signs on the estate confirmed its involvement in the production.


The crew were spotted filming in Aberdeenshire in 2024.

Veteran's tribute to families left bereft by deaths during wartime

An 85-year-old Royal Navy veteran has urged people to remember not only those who died in conflicts but the families they left behind on Remembrance Day.

George Walker was around four years old when he met his father Harry for the only time before he was killed at sea at the age of 27 during the Second World War.

His father was in the trawler fleet which came under the Merchant Navy & Reserved Occupations.

He died when his ship, the Strathlyon, was hit by a mine off Iceland in 1943.

Mr Walker, who lives at Erskine's Veterans Home in Edinburgh, remembers meeting his father only once when he came home from sea. He has urged people

to remember the relatives of those who gave their lives for their country as the nation prepares to mark Remembrance Day tomorrow.

He said: "When the silence falls at 11am, my mind always goes straight to my father.

"He died so young, at 27, and I never had the chance to know him. I

often wonder what kind of father he might have been to me.

"It's not just about soldiers in battle, it's about the empty chairs at the table, the children who grew up without parents, and the families who had to find a way to carry on.

"That's what remembrance means to me."

The north-east joined the rest of the UK yesterday in honouring the nation's fallen war heroes as Remembrance Sunday events and tributes took place across the region.

Aberdeen paid tribute with a military parade, civic procession and wreath-laying ceremony at the war memorial on Schoolhill in Aberdeen.

Starmer is no better than Boris

Prime Minister Keir Starmer has been compared to bungling Boris Johnson following his "brazen betrayal" of Scotland and its fishing industry.

SNP MP Seamus Logan, whose Aberdeenshire North and Moray East includes two of the largest fishing ports in Peterhead and Fraserburgh, said the Labour government's sums and excuses "don't add up" following the allocation of the £360 million Fishing and Coastal Growth Fund.

He raised the matter at Westminster last week with UK Fisheries Minister Angela Eagle MP, whose dismissive response was the funding had been allocated to the devolved governments in the normal way by using the Barnett Formula - and that the Scottish Government should use other funding it has received if it wants to support the fishing industry.

Mr Logan said: "My urgent question clearly showed that not only do the Labour Party's sums not add up, their excuses don't add up either.

"They have cut Scotland's fair share of this fishing fund by 83 per cent and they now have the brass neck to tell Scotland's coastal communities that they should be more grateful.

"Keir Starmer is clearly taking the Boris Johnson approach on how to brazenly betray Scotland's fishing industry.

"Scotland has a cast iron case for a fair share of fisheries funding. By not funding Scotland fairly, the UK Labour government is choosing to funnel massive financial support to England's fisheries at Scotland's expense.

"When we were still part of the EU, we received 46% of funds based on our share of the UK fishing sector. We were led to believe that Labour's Fishing and Coastal Growth Fund would replicate this allocation - but Labour's habit of breaking promises strikes again.

"This is another example of a broken Westminster

system that doesn't work for Scotland - coastal communities and rural Scotland marginalised by a UK Government that is making decisions from afar, with little or no knowledge of the communities they are harming."

Scottish Conservative fishing spokesman Tim Eagle MSP described Scotland's allocation as a pitiful amount which did not come close to the true scale that Scotland's fishing sector benefits the UK.

"It is a drop in the ocean when almost 40% of fishermen are based here in Scotland, landing substantially more fish than anywhere else in the UK," he said. "The significant gap between the funding that has been made available to Scotland, compared to Scotland's overall output, is neither fair nor proportionate."

"This short-changes Scotland and will do little to ease the anger that fishermen rightly feel towards Keir Starmer for surrendering our fishing waters to the EU until 2038. Once again, we are seeing this Labour UK Government undervalue our fishing industry."

Scottish Conservative colleague and North East MP Andrew Bowie said the allocation of the Fishing and Coastal Growth Fund proved Labour "has absolutely no regard for Scotland's totemic fishing industry".

erdeenshire and 58 in Moray – resulting from 273 collisions.

Of those injured in Aberdeenshire, 123 suffered serious injuries.

Gordon and Buchan MP Harriet Cross has described the figures as “horrifying” and has slammed the Scottish Government for turning the North-east into the “road death capital of Scotland”.

The MP hit out at ministers for pausing the dualing of the A96, refusing to upgrade the A90 between Ellon, Peterhead and Fraserburgh, and stalling on improving the A90 Laurencekirk junction.

The Scottish Conservative MP said: “These horrifying figures are the tragic reality of the Scottish Government’s lack of action to dual roads such as the A96 and A90 in the North-east.”

Across Scotland, 161 people lost their lives in collisions on the roads.

A further 5,573 people were injured, including just under 2,000 people who suffered serious injuries.

North-east roads have been named the most dangerous in Scotland after 24 people were killed on routes across the region last year.

Annual figures released by Transport Scotland show the North-east had the highest number of road fatalities in the country in 2024.

Transport Scotland’s statistics showed the 24 fatalities occurred from 22 collisions last year, a rise of 10 collisions on 2023 when 12 were recorded.

Of the 24 deaths, 12 occurred on roads in Aberdeenshire, nine happened in Moray, and three in Aberdeen.

Further 384 people were injured on North-east roads – 82 in Aberdeen, 244 in Ab-

Rent increases

Rent in Aberdeen and Shire rose 4 per cent over the past year, new figures show.

Provisional figures from the Office for National Statistics show the average private rent in the Aberdeen and Shire rental market area reached £854 per month in the year to September – up 4 per cent from £825 a year prior. It was also up 24 per cent from an estimated £689 per month five years ago.

Scotland’s rent data is collected by Rent Service Scotland, and is predominantly for advertised new lets, with only a small proportion based on existing tenancies. Therefore, price changes for existing tenancies are largely estimated.

Across Scotland, the average rent was £1,004.

Lothian had the highest rental cost in the country at £1,397 per month, while the lowest was in Dumfries and Galloway at £527.

Call for a fair deal for rural Scotland

The Scottish Liberal Democrat autumn conference has backed proposals which would ensure that all legislation works for rural communities.

The motion also called for a review of the shape and size of rural local authorities, and funding formulas – subject to their request – to ensure local services are properly resourced and meet the needs of local communities.

It was backed overwhelmingly by conference.

Speaking in support of the motion, the Liberal Democrats Lead Scottish Parliamentary Candidate for the North East Region Yi-pei Chou Turvey (pictured) said: “In rural areas like Aberdeenshire and Angus the risk of losing our local schools, our rural nurseries, our bus routes and our local health ser-


vices is hanging constantly over families’ heads.

“For fishermen, farmers and other rural workers there is no working from home – their work is where it is, and we need for support our rural communities.

“As representatives of North-east communities, we are facing death by a thousand cuts and anger in our communities is growing.
